**ADMISSION NOTIFICATION FOR POST GRADUATE DENTAL MDS COURSES FOR
THE ACADEMIC YEAR 2019-20 FOR COMPETENT AUTHORITY QUOTA IN THE
STATE OF TELANGANA**

Application forms through online are invited for admission into Post Graduate Dental MDS courses for the academic year 2019-20 into affiliated colleges to KNR University of Health Sciences, Warangal in the state of Telangana from the eligible candidates who have secured the following cut-off scores and above in NEET MDS 2019 for preparation of State Merit list in the Website <https://tsmds.tsche.in/> from 10.00 AM on 27-03-2019 to 01-04-2019 up to 5.00 p.m only.

Notification issued is for determining State Merit position for admission into Competent Authority Quota seats only. Total number of seats available under competent authority quota for the academic year 2019-20 will be notified later. Fee structure will be as fixed by the Government and relevant hon'ble High Court Orders .

Cut-off marks for Post Graduate Dental MDS courses:

- I. Candidates should have secured the following cutoff score or above in NEET - MDS 2019 (as per the notice of NBE dated: 14-01-2019)

Category	Eligibility Criteria	Cutoff Score (out of 960)
General	50 th Percentile	250
SC/ST/BC	40 th Percentile	215
OC/PH	45 th Percentile	232

State Merit position of the applied candidates will be prepared based on NEET MDS – 2019 Score and other eligibility criteria notified hereunder.

ELIGIBILITY :

- A) Candidate should have qualified in NEET MDS-2019 by securing marks of cut-off score or above.
B) Candidate should have passed BDS Degree examination from an Institution in recognized by the Dental Council of India.
C) Candidates should have registered with Dental Council of India / State Dental Council.

NOTE: The candidates those who have already completed internship should submit completion certificate. The candidates those who will be completing internship by 31-03-2019 shall submit provisional likely to complete internship completion at the time of verification of certificates.

- D) Candidates who satisfy the Local / Non Local status as per G.O.P No.646 Education (W) Department Dt: 10.07.1979 only are eligible to apply for determining the State Merit position

for Competent authority quota seats in respective categories using NEET MDS– 2019 score. Candidates are informed to read the prospectus carefully regarding eligibility criteria before applying online.

- II. The NEET MDS 2019 qualified and eligible candidates as per concerned regulations who desire to take admission in to PG Dental Degree MDS Courses shall apply through online for determining the Merit position for Telangana State competent authority quota of respective categories using NEET MDS 2019 scores in the Website <https://tsmds.tsche.in/> from 10.00 AM on 27-03-2019 to 01-04-2019 up to 5.00 p.m only.

The online application can be filled through any computer with internet connection (home/internet café/net center). The printout of filled-in application along with enclosures in two (2) sets should submit at the time of verification of original certificates as per the notified schedule at help-line centers by KNR University of Health Sciences.

- 1.Registration Fee for MDS Degree courses :- The Registration fee of Rs.3800/- (Bank transaction charges extra)for OC & BC candidates and Rs.3300/- (Bank transaction charges extra) for SC/ST candidates shall be paid online through Debit card / Credit card or Net Banking.**

** Registration fee once paid will not be refunded or adjusted to a further date.

** Candidates are advised to check their eligibility to apply for determining the Merit position in respective categories by using NEET MDS - 2019 score by reading Prospectus / Regulations carefully.

Candidates who completed BDS from other state must pay equivalency verification / certificate verification fee along with the registration fee. The verification fee and registration fee once paid will not be refunded or adjusted to a future date. Therefore candidates are advised to check eligibility conditions thoroughly before applying for determining merit position in respective categories for State quota seats using NEET MDS - 2019 Scores.

- 2.For information on SC/ST/BC/PWD Reservations and Weightage of marks for in- service candidates and other details read the Prospectus carefully. The Prospectus of the course, Instructions for filling of Online Application is available on the University Website: www.knruhs.in

- 3.The candidates are advised to download and read the Prospectus of the course and instructions for filling Online Application available in the website before filling the online Application

- 4.Procedure of filling online application and Procedure for online payment for PG DENTAL Degree MDS Courses

- i). The registration fee can be paid through Debit card / Credit card or Net Banking
- ii). The registration fee paid by the applicants is not refundable under any circumstances. iii). Read the Notification, Prospectus / Regulations carefully.
- iv). The following documents are required:
 - (a) Admit card and Score Card – NEET – MDS 2019 .
 - (b) Aadhar Card
 - (c) Date of Birth Certificate.(SSC or its equivalent certificate)

(d) Study Certificate(s) from 1st BDS to final BDS.

(e) In case of candidates from Govt. Dental College, Hyderabad, Govt. Dental College, Vijayawada, and Army Dental College, Secunderabad/ study certificates from VI class to Intermediate.

(f) All marks memos from First BDS to final BDS.

(g) Latest Category status certificate issued by Govt. of Telangana if applicable.

(h) Internship completion certificate / Provisional Internship completion vide Annexure-IV C of prospectus.

(i) Dental Council Registration Certificate.

(j) Latest Service certificate issued by the concerned Head of the Department, if applicable.

v). Visit website through Internet Explorer (11.0) to fill the application form.

vi). Fill all the details in the online application form.

5. Procedure for submission of filled-in online Application form for PG Dental I Degree MDS courses:- The candidate should submit the print-out of the filled-in Online application form in person along with two (2) sets of self attested copies of required certificates at the time of certificate verification at notified centers.

6. Note:

a). On-line application forms received at the time of verification of original certificates without copies of the required Certificates, Passport size photo, without signature at declaration area, incomplete applications will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET –MDS- 2019 score.

b). Candidates admission to the counseling for verification of original certificates for KNR UHS MDS 2019 admissions is strictly provisional. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.

c). Candidates may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., educational qualifications, validity of registration with DCI/State Dental Council, Internship, local / Non Local area status, category status after duly verifying all the relevant certificates in original at the time of verification of original certificates . If the information furnished by the candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken.

d). Mere submission of application through Online is not sufficient. Candidates eligibility for admission to PG Dental courses 2019-20 session will be examined by the University only after submission of printout of application (hard copy) along with all copies of required certificates at the notified centers for verification of original certificates on specified dates.

e) Verification of Original Certificates shall be conducted on 03-04-2019 at the centers notified as per schedule given by the University on KNRUHS website. No separate paper notification will be given. Candidates are advised to refer to KNRUHS website for further details regarding schedule of verification of Original Certificates.

- f). Candidate should attend in person without fail with Original Certificates and self attested copies. The verification of Original certificates will be done only once irrespective of the number of times of exercising web options. Therefore the candidates should attend verification of Original Certificates without fail on 03-04-2019 as per the schedule notified on the website.
- g). The Orders issued from time to time by Government with regard to process of Admissions to Post Graduate Dental Courses and relevant Hon'ble Supreme Court and Hon'ble High Court orders shall be applicable.
- h). This notification is for determining the State Merit position in respective categories using NEET – MDS- 2019 score only. The dates for exercising web options for admission to PG Dental courses (MDS) courses and procedure will be notified separately on University website. Candidates are advised to referred to University for notifications, schedules and other details from time to time.
- i). An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
- j). Admission will be considered only for candidates, who have secured marks above cutoff score in NEET- MDS-2019 exam and based on the state merit order as the case may be.
