## ADMISSION INTO MBBS/BDS COURSES FOR THE YEAR 2019-20

### NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR FINAL PHASE OF WEB-BASED COUNSELING FOR ADMISSION INTO MBBS/BDS COURSES UNDER COMPETENT AUTHORITY QUOTA IN GOVERNMENT, PRIVATE UN-AIDED MINORITY, PRIVATE UN-AIDED NON-MINORITY MEDICAL COLLEGES, GOVERNMENT, PRIVATE UN-AIDED DENTAL COLLEGES AND ARMY DENTAL COLLEGE AFFILIATED TO KNR UHS,

In continuation of earlier notifications dated 06.07.2019,16-07-2019 KNR University of Health Sciences hereby notifies the conduct of final phase of counseling for filling up the vacant seats in MBBS/BDS courses after second phase of counseling under Competent Authority Quota (A-Category) including special categories NCC, CAP and EWS Quota seats into affiliated Government, Private Un-aided Minority, in Government/Un-aided Non-Minority/ Minority Medical Colleges and Government / Un-aided Non-Minority Dental colleges / Army Dental Colleges and vacant seats reverted from All India Quota .

Candidates can exercise web options as per the schedule given below in the web-site <https://tsmedadm.tsche.in>

The details of seats available will be placed in the web-site <http://knruhs.in> and <https://tsmedadm.tsche.in>

All the candidates in the final merit list displayed on KNR UHS, web-site on 6-07-2019 are eligible to exercise web-options subject to fulfillment of following conditions. Candidates whose names are displayed in CAP and NCC Merit lists are also informed to exercise web options. Candidates who have been shown as being eligible for EWS quota in the final merit list are also informed to exercise web options. Candidates who have secured admission in the previous phases of counseling and joined the course and continuing in the course, who wish to slide to other college / course also can exercise their options.

The candidates who have been allotted seats in the second phase of counseling and who have not joined / discontinued the course after joining are not eligible to exercise options for final Phase of counseling. Candidates who have joined the course in All India Quota / Deemed Universities Counseling are not eligible to exercise options for Final Phase of counseling as per the orders of Hon'ble Supreme Court and Medical Counseling Committee (MCC) of Government of India. Candidates who have joined MBBS Course in colleges under Dr.NTRUHS, Vijayawada are informed not to exercise web options, as the MBBS course admitted candidates under Dr.NTRUHS are not permitted to discontinue the course after 17.8.19 as per notification issued by Dr.NTRUHS.

Allotment of seats will be done as per the procedure following G.O.Ms.No.114 HM&FW(C1) Dept. Dated:05-07-2017 and other Government regulations and Hon'ble High Court orders in WP No.16637 of 2019. Candidates are informed that the allotments are also subject to final orders in all pending writ petitions in respective courts.

**UNIVERSITY FEE:** Rs. 10,000/- for both MBBS and BDS Courses have to be paid for obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

**TUITION FEE:** As per existing Government guidelines for Govt. / Pvt. (Minority/ Non-Minority) Medical & Dental Colleges and Army Dental College.

List of seats vacant due to non joining of candidates after second phase of counseling is displayed on KNRUHS web-site. Vacancies of reverted All India Quota seats will also be displayed in seat matrix separately. Seat matrix for Seats sanctioned for implementation of EWS quota also is displayed on website separately. Candidates while giving options should note that apart from vacant seats, seats vacated by candidates sliding during this phase of counseling will be added and allotted simultaneously during this phase of counseling. The allotted seat under second phase counseling will be cancelled automatically if the candidate is allotted a seat in final phase of counseling as per his/her option.

#### **IMPORTANT INSTRUCTINOS TO THE CANDIDATES :**

- 1) The candidates can exercise web options through <https://tsmedadm.tsche.in> from home or any other place having internet facility. Use only system with Internet Explorer version 11. Do not use Tabs or Mobiles to exercise web-options.
- 2) Candidates can make use of help-line centers at K.U. Campus, Warangal, and PGRRCDE, OU Campus, Hyderabad for exercising web- options from 9.00 A.M. 5.00 P.M. on 20.08.2019, 21.08.2019 and from 9.00 AM to 11.00 AM on 22.08.2019.

- 3) Candidate can exercise options for MBBS/BDS Courses for all the Colleges as per the eligibility. There is no limit to the number of options. Candidates can exercise options for colleges and courses in which they are interested to join irrespective of vacancies displayed as seats may be added-up due to sliding.
- 4) Candidates are advised to read the regulations and prospectus carefully before exercising web-options.
- 5) **Candidates are informed that they have to give options to the course and colleges in which they are interested to join. In case the candidate does not join the course in the college after allotment he / she will not be eligible to exercise web-options for mop up round to be conducted in case of any vacant seats arise after final phase of counseling .**
- 6) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z.
- 7) Candidates are instructed to take a print out of saved options.
- 8) Candidates will receive the message on their registered mobile after allotment of seat, if allotted. Candidates can also check the allotment list on website for knowing the allotment.
- 9) Candidate has to down-load the allotment letter by paying the University fee through payment gateway. Candidates who have already paid University fee in the previous phases of counseling need not pay again.
- 10) Candidate has to take print out of allotment order, check their allotment and report to Principal of respective college before the date specified on the allotment letter.
- 11) The selected candidates shall report to the Principal with all original certificates, bond, and pay the college fee before the last date and time at the allotted college as mentioned in the allotment letter.
- 12) Candidates slided from one college to another college have to take back their original certificates, bond and tuition fee from the admitted college of second phase of counseling and report to the principal with original certificates, bond and pay the tuition fee at the college allotted in the final phase.
- 13) The University fee and other fees once paid shall not be refunded under any circumstances.
