Sub: Cancellation of the seat of the student admitted in ASU& H UG courses in 1st & 2nd round of All India counselling-Reg.

Sir/Madam,

I am directed to refer to subject cited above and to say that as per approved counselling scheme, the students admitted in 1st round of all India Counselling were allowed to surrender their seat during specific time period (04th Aug to 09th Aug) and the student admitted in 2nd round of All India Counselling were not allowed to vacate their seat.

2. Further, many representations' has been received from the candidates admitted in ASU& H UG courses through All India counselling for cancelation of their seat due to admission in other professional courses like MBBS, Engineering etc.. Furthermore, many college representatives including National Institute's, Government Colleges, Deemed University and private colleges (Principal/Dean/Reporting Officer) have asked telephonically regarding the cancelation of the admission of the student admitted in ASU& H UG courses in 2nd round of All India counselling

3. This issue has been discussed in the meeting of AACCC on 23.08.2019 and competent Authority has decided that, considering the future/career of students, exit from 1st and 2nd round of All India Counselling may be allowed subject to rules/regulations/bond conditions (If applicable) of the concerned state, where college is situated.

4. Therefore, all college Dean/Principal/Director may consider the request of candidates admitted in 1st and 2nd round of All India Counselling and cancel their seat subject to condition stipulated in para 3 above. **For this, facility of seat surrender will be available from 30th Aug 2019 to 5th September 2019 only.**

5. College Dean/Principal/Director has to cancel the admission of such candidate through Admin Login software only (during 30th Aug 2019 to 5th September 2019). Offline cancelation of seat will not be entertained.

6. Accordingly, vacancy of seats created by seat cancellation during 30th Aug 2019 to 5th September 2019 may be transferred to the state counselling authority, under intimation to the Ministry

7. This issues with approval of competent authority.
