**NOTIFICATION FOR EXERCISING WEB-OPTIONS FOR MOP-UP ROUND
OF COUNSELING FOR ADMISSION INTO BDS COURSE FOR VACANT
SEATS UNDER COMPETENT AUTHORITY QUOTA AFTER FINAL PHASE
OF COUNSELING IN GOVERNMENT AND PRIVATE DENTAL COLLEGES
AFFILIATED TO KNR UHS, WARANGAL IN THE STATE OF TELANGANA**

In continuation of earlier notification dated 06.07.2019, 16-07-2019, 19-08-2019 KNR University of Health Sciences hereby notifies to conduct Mop-up round of counseling for filling up the vacant seats in BDS course after Final phase of counseling under Competent authority quota (A-Category) in Government and Un-aided Non-Minority Dental Colleges affiliated to Kaloji Narayana Rao University of Health Sciences in the state of Telangana.

Candidates can exercise web options as per the schedule given below in the web-site <https://tsmedadm.tsche.in>

Rank in the final merit list of KN R UHS,	Dates for exercising web-options
1 to Last rank	From 6.00 P.M. on 10-09-2019 to 5.00 P.M. on 11-09-2019

All the candidates in the final merit list displayed on KNR UHS, web-site on 06-07-2019 & candidates registered after lowering of NEET UG 2019 cutoff score and in the merit list to be displayed on KNRUHS website on 10-9-2019 are eligible to exercise web-options.

Candidates who have been allotted seats for BDS Course in the second and third phase of counseling as per their options and have not joined or discontinued the course at respective colleges will not be permitted to exercise options as per G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017 and as notified earlier. Candidates who are already admitted in MBBS/ BDS course under All India Quota i.e., State Quota (15 %) and Deemed / Central Universities are not eligible to exercise web-options. Candidates who have joined MBBS/BDS Course at colleges affiliated to Dr.NTRUHS are not eligible to exercise options, as per notification issued by Dr.NTRUHS candidates are not permitted to discontinue from the course and to prevent dual blocking of seats.

Allotment of seats will be done as per the procedure following G.O.Ms.No. 114 HM&FW(C1) Dept. Dated:05-07-2017, subsequent amendments, other Government regulations and orders of Hon'ble High Court of Telangana.

Candidates who have secured admissions and joined in the previous phases of counseling and continuing in the course in colleges under KNRUHS who wish to slide to other college / course also can exercise their options.

UNIVERSITY FEE:	Rs. 10,000/- (Non Refundable) for BDS Course has to be paid for obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking). Candidates who have paid University fee in previous phases of counseling need not pay University fee again.
TUITION FEE:	As per existing Government guidelines for Govt./ Non-Minority) Dental Colleges.

NOTE :

1) List of seats vacant due to non-joining will be displayed on KNRUHS web-site after the information is received from respective colleges.

2) Candidates while giving options should note that apart from vacant seats, seats vacated by candidates sliding during Mop-up round of counseling will be added and allotted simultaneously during Mop-up round of counseling only. The allotted seat of previous phases of counseling will be cancelled automatically if the candidate is allotted a seat in Mop-up round of counseling as per his/her option.

3) Candidates are hereby informed that as this is the last phase of counseling for BDS course, those who are allotted seats should compulsorily join in the course or they will be liable to pay of Rs. 3,00,000=00 (Rupees Three Lakhs). Candidates who have joined already and discontinue also have to pay the same along with tuition fee. Candidates who do not join or discontinue from the course will be debarred for three years from participating in further counseling for BDS admissions.

IMPORTANT INSTRUCTINOS TO THE CANDIDATES :

- 1) The candidates can exercise web options through <https://tsmedadm.tsche.in> from home or any other place having internet facility. Use only system with Internet Explorer version 11. Do not use Tabs or Mobiles to exercise web-options.
- 2) Candidates can make use of help-line center at PGRRRCDE, OU Campus, Hyderabad, JNTUH Kukatpally, Hyderabad, Counselling centre at Kakatiya University, Warangal for exercising web- options from 9.00 A.M. to 5.00 P.M. on 11-09-2019.
- 3) Candidate can exercise options for BDS Course for all the Colleges as per the eligibility. There is no limit to the number of options. Candidates can exercise options for colleges in which they are interested to join irrespective of vacancies displayed, as seats may be added-up due to sliding.
- 4) Candidates are advised to read the regulations and prospectus carefully before exercising web-options.
- 5) Candidates are informed that they have to give options to the colleges in which they are interested to join. In case the candidate does not join the course in the college after allotment he / she will be subject to penal action as per existing Government / University regulations.
- 6) Candidates already joined in colleges under DR.NTRUHS and who are continuing in the course under Competent Authority Quota are here by

informed that they are not eligible for Mop-up Round of counseling for BDS Course as they are not permitted to discontinue the course and in order to prevent dual blocking, seats wastage and seat blocking.

- 7) As notified earlier, candidates who have not joined after allotment in the Second and final phases of counseling for competent authority quota or discontinued the course are not eligible for exercising web-options for the same course in the Mop-up Round of counseling.
- 8) One time pass word will be sent to the registered mobile number at the time of exercising web-options. The pass word consists of SIX letter code with English capital A to Z.
- 9) Candidates are instructed to take a print out of saved options.
- 10) Candidates will receive the message on their registered mobile after allotment of seat, if allotted.
- 11) Candidate has to down-load the allotment letter by paying the University fee through payment gateway.
- 12) Candidate has to take print out of allotment order, check their allotment and report to Principal of respective college before the date specified on the allotment letter.
- 13) The selected candidates shall report to the Principal with all original certificates, bond, and pay the college fee before the last date and time at the allotted college as mentioned in the allotment letter.
- 14) If a candidate is already admitted in colleges under KNRUHS and slided to other college he / she has to report at the allotted college with custodian certificate(Original Receipt of Certificates) and relieving order from Principal of previous college . Original certificates will be transferred by the principal to the allotted college after closure of admissions.
- 15) Candidates admitted under Competent authority quota are not permitted to discontinue the course after free exit on 05-09-2019 after 2.00 P.M. In case the candidate wants to discontinue from BDS course, original certificates will be returned to candidates after closure of admissions on payment of discontinuation fee and tuition fee for entire course and the candidate will be debarred for admissions under KNRUHS for 3 years
- 16) The University fee and other fees once paid shall not be refunded under any circumstances.
