Application forms through online are invited from Indian Nationals / NRIs for admission into Management Quota seats of Post Graduate Medical Degree / Diploma and MDS courses for the academic year 2018-19 into Private Non-Minority Medical and Dental colleges and Minority Medical Colleges affiliated to KNR University of Health Sciences, Warangal in the state of Telangana from the eligible candidates who have fulfilled the following conditions and secured the following cut-off scores and above in NEET PG 2018 / NEET MDS 2018.

Notification issued is for determining Merit position for admission into Management Quota seats only. Total number of seats available under Management Quota for the academic year 2018-19 will be notified on KNRUHS website before on-line counseling. Fee structure will be as fixed by the Government as per G.O.Ms.No41 HM&FW(C1) Dept.Dt .9-5-2017 and G.O.Ms.No. 43 HM&FW (C1) Dept. Dated:09-05-2017.

1. ELIGIBILITY:

- A) Candidate should have qualified in NEET PG-2018 / NEET MDS 2018 by securing marks of cut-off score or above.
- B) Candidate should have passed MBBS Degree/BDS examination from an Institution recognized by the Medical Council of India / Dental Council of India.

NOTE: The candidates those who have already completed internship should submit completion certificate. The candidates those who will be completing internship by 31-03-2018 shall submit provisional likely to complete internship completion at the time of verification of certificates.

2. The NEET PG 2018/ NEET-MDS 2018 qualified and eligible candidates as per concerned regulations who desire to take admission in to Management Quota PG Medical Degree/Diploma /MDS Courses shall apply through online for determining the Merit position for Management quota seats using NEET PG 2018 / NEET MDS 2018 scores in the Website

http://pvttspgmed.tsche.in/ from 10.00 AM on <u>02-04-2018</u> to 7-04-2018 up to 5.00 p.m only. The online application can be filled through any computer with internet connection (home/internet café/net center). The printout of filled-in application along with two (2) sets self attested xerox copies of relevant certificates should be submitted at the time of verification of original certificates and on-line counseling as per the notified schedule by KNR University of Health Sciences at counseling center.

- 3. Registration Fee for PG Degree/Diploma courses :- The Registration fee of Rs.3800/(Bank transaction charges extra) shall be paid online through Debit card / Credit card or Net Banking.**
 - ** Under any circumstances fee once paid will not be refunded or adjusted to a further date.
 - ** Candidates are advised to check their eligibility to apply for determining the Merit position by using NEET PG 2018 NEET MDS 2018 score by reading Prospectus / Regulations carefully.
- 4. For other details read the Prospectus for Management Quota admissions carefully. The Prospectus of the courses, Instructions for filling of Online Application is available on the University Website: www.knruhs.in
- 5. The candidates are advised to download and read the (1) Management quota Prospectus of the course (2) Instructions for filling Online Application available in the website before filling the online Application
- 6. Procedure of filling online application and Procedure for online payment for PG Medical Degree/Diploma Courses
 - 1. The registration fee can be paid through Debit card / Credit card or Net Banking
 - 2. The registration fee paid by the applicants is not refundable under any circumstances.
 - 3. Read the Notification, Prospectus / Regulations carefully.

- (g) Internship completion certificate / Provisional Internship completion vide Annexure-IV C of prospectus.
- (h) Medical Council Registration Certificate.
- (i) NRI Sponsorship certificate / NRI Certificate if applicable.
- 5. Visit website through Internet Explorer (11.0) version to fill the application form.
 - 6. Fill all the details in the Online application form.
- 7. Procedure of filling online application and Procedure for online payment of

Procedure for submission of filled-in online Application form for PG Medical Degree/Diploma courses:-The candidate should submit the print-out of the filled-in Online application form in person along with two (2) sets of self attested copies of required certificates at the time of certificate verification at notified centers.
- 9) The PG Degree / Diploma seats available under Management Quota in Private un-aided Non-Minority /

Minority Medical Colleges is separately shown as annexure - 1.

- 10. The PG MDS seats available under Management Quota in Private un-aided Non-Minority Dental Colleges is separately shown as annexure 2
- 11. Final seat matrix for Management Quota sub-category MQ.-1, MQ.1, MQ-3 will be displayed on KNRUHS website i.e. www.knruhs.in before online counseling.
- 9. <u>Note</u>:
- 1. Provisional merit list will be displayed on KNRUHS on website on 10-04-2018.
 - 2. Candidates attending for verification of original certificates without print out of on-line application form, copies of the required Certificates, Passport size photo, without signature at declaration area, incomplete applications, DD for University fee amount will not be considered for on-line counseling and allotments of seats using NEET PG- 2018 / NEET MDS 2018 Score.
 - 3. Candidates admission to the counseling for verification of original certificates for KNR UHS 2018 Medical & Dental admissions is strictly provisional. The mere fact that the Merit position issued to him/her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the online application are accepted as true and correct.
 - 4. He/she may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., educational qualifications, validity of registration with MCI/State Medical Council, DCI, Internship completion Certificate, Minority status certificate (if applicable) and after duly verifying all the relevant certificates in original at the time of verification, candidate will be considered for allotment of seat. If the information furnished by him/her in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken

- 5. Verification of Original Certificates and on-line counseling shall be conducted from at the PGRRCDE O U Campus Hyderabad as per schedule to be notified by the University on website. No separate paper notification will be given. Candidates are advised to refer to KNRUHS website for further details regarding schedule of verification of Original Certificates and on-line counseling.
 - 6.. Candidate should attend in person without fail with Original Certificates and self attested copies.
 - 7.. The Orders issued from time to time by Government(s) with regard to Admissions to Post Graduate Medical Courses under Management Quota and relevant Hon'ble Court directions shall be applicable.
- 8. This notification is for determining the Merit position using NEET PG 2018 / NEET MDS 2018 score only.
 - 9.. An in-eligible candidate obtaining Merit position does not make him/her eligible for admission.
- 10. Admission will be considered only for candidates, who have secured marks above cutoff score in NEET- PG-2018/NEET MDS 2018 exam and based on the merit order as the case may be.
