ORDER:

In the G.O.1st read above, the Government have issued Rules for admissions (inclusive of seat matrix) into Under Graduate AYUSH (viz. Ayurvedic, Homoeopathy, Unani, Naturopathy, Yoga) in Un-aided Non-Minority AYUSH Medical Institutions in the State.

2. In the G.O.2nd & 3rd read above, the Government have issued orders for fixing the fee structure for Professional Courses of BAMS, BHMS and BNYS for the block period of 2011-12, 2012-13 & 2013-14.

3. In the G.O.4th read above, the Government have issued orders amending the Telangana Un-aided Non-Minority AYUSH Medical Colleges fixing the seat matrix and formulation of admission procedure.

4. In the G.O. 5th read above, the Government have issued orders fixing the fee structure and certain directions to all the Private Un-aided Non-Minority Ayush Medical Colleges in the State of Telangana for the academic years 2016-17; 2017-18 and 2018-19.

5. In the letters 6th read above, the Director (I/c), Department of Ayush, Telangana State, Hyderabad has submitted a proposal keeping in view of implementation of NEET (UG) in the admissions. He has therefore requested the Government for changing of percentage of category i.e. A – 50%, B- 35% and C-15% and also fee structure in all the private un-aided non-minority AYUSH, Homoeopathic Medical Colleges in the State of Telangana.

6. The Government after careful examination of the matter, hereby order for implementation of the following Seat Matrix to all the Private Un-aided Non-Minority Ayush Medical Colleges in the State of Telangana and also order for change of Fee Structure to three (3) private un-aided non-minority AYUSH Homoeopathic Medical Colleges, as shown below:

Seat Matrix: The percentages of the categories are as follows:

- i. Category –A seats i.e Competent authority seats (50% of the sanctioned intake of the seats):-** These seats shall be filled in through the counseling by the Committee constituted by competent authority based on the merit from the candidates who are qualified in NEET (UG) held by the Government of India for that year by following the rules of reservation.
- ii. Category – B seats i.e NEET (UG) qualified ranking based Management seats (35% of the sanctioned intake of the seats):-** The seats shall be filled through the counselling by the Committee for admissions constituted by competent authority (Vice Chancellor of KNRUHS) based on the merit from the candidates who are qualified in NEET (UG) for that year. The Committee constituted will include one nominee of Telangana Private AYUSH Colleges Management Association and Director (I/c), Department of Ayush, Telangana State, Hyderabad. The Registrar, Kaloji Narayana Rao University of Health Sciences, Telangana State, Warangal will be the Convener. KNR UHS Officers will assist the selection committee. The notification will be issued by the Kaloji Narayana Rao University of Health Sciences, Telangana State, Warangal and admission process will be completed as per the schedule by the Selection Committee constituted by the Vice Chancellor.

- iii. **Category – C seats (15% NRI quota):-**These seats shall be filled by the competent authority i.e. Vice Chancellor of Kaloji Narayana Rao University of Health Sciences, Telangana State, Warangal through Selection Committee constituted for category B-seats and a notification will be issued by the Kaloji Narayana Rao University of Health Sciences, Telangana State, Warangal, for NEET (UG) qualified NRI candidates. Eligibility criteria for NRI candidates admissions shall be as per CCIM / CCH Regulations, issued from time to time.

Fee Structure

The following fee structure shall be implemented in the following private un-aided non-minority AYUSH Homoeopathic Medical Colleges in the State of Telangana:

1.	JIMS Homoeopathic Medical College, Shamshabad.	Rs.40,000/-	Rs,5,00,000/-	Maximum not exceeding twice of "B" Category
2	M.N.R Homoeopathic Medical College & Hospital, Sangareddy	Rs.40,000/-	Rs.3,00,000/-	Maximum not exceeding twice of "B" Category
3	Dev's Homoeopathic Medical College & Hospital, Keesara, Medchal District.	Rs.40,000/-	Rs.3,00,000/-	Maximum not exceeding twice of "B" Category

7. These orders shall come into force with immediate effect. The Registrar, Kaloji Narayana Rao University of Health Sciences, Telangana State, Warangal and the Director I/c., Department of AYUSH, Telangana State, Hyderabad shall take necessary action accordingly. All the Principals of all Private Unaided Non-Minority Ayush Medical Colleges shall also take necessary action in the matter.
