In the G.O. 1<sup>st</sup> read above, the Government have issued orders for fixation of fee structure and directions for M.Sc (Nursing) Course in Private un-aided M.Sc. Nursing Colleges in the State for the Academic years 2008-09; 2009-10 and 2010-11.

In the G.O.2<sup>nd</sup> read above, the Government have issued orders for fixation of fee structure and directions for General Nursing and Midwifery Courses, MPHWH (F), DMLT and other Paramedical courses in Private un-aided Nursing and Para Medical Institutions in the State for the academic years 2008-09; 2009-10 and 2010-11.

In the G.O.3<sup>rd</sup> read above, the Government have issued orders for fixation of fee structure and directions for B.Sc. (Nursing); Post Basic B.Sc. (Nursing); B.Sc. (MLT); BPT & MPT courses in Private un-aided Nursing and Para Medical Institutions in the State for the Academic years 2008-09; 2009-10 and 2010-11.

In the 4<sup>th</sup> read above, the Government have issued amendment orders for seat matrix as 60% for Convenor Quota and 40% Management Quota for all paramedical and Nursing courses viz., B.Sc (Nursing); GNM, Multi Purpose Health Workers (Female); BPT; B.Sc (MLT); DMLT and other Paramedical Courses w.e.f. the academic years 2011-2012 onwards .

In the 5<sup>th</sup> read above, the Government have issued orders for retaining the fee structure for GNMC, MPHWH(F), DMLT and other Paramedical Courses and B.Sc (Nursing), P.B.B.Sc (Nursing), B.Sc (MLT), BPT, MPT courses for the Academic year 2013-2014.

In the representation 6<sup>th</sup> read above, the President, Health Education Institutions Management Association, Hyderabad has represented to fix the fee structure for various nursing courses and fixation of uniform / common fee structure for free and management quota seats.

The Government have communicated the Official Committee Report for revision of fee structure for various nursing courses and fixation of uniform / common fee structure for free and management quota to the Telangana Admission and Fee Regulatory Committee (TAFRC) and requested detailed recommendations of the TAFRC, vide letter 7<sup>th</sup> read above.

In the letter 8<sup>th</sup> read above, the Telangana Admission and Fee Regulatory Committee has recommended the fee structure as each Institutions / Colleges wise for the block period 2016-17; 2017-18; 2018-19.

After careful examination of the matter, the Government have decided and hereby order the following fee structure for M.Sc (Nursing); B.Sc (Nursing), Post Basic B.Sc (Nursing); GNM; ANM / MPHWH (F); MPT; BPT; DMLT & other Para Medical Diploma and B.Sc. MLT Courses in Private Un-aided Nursing & Para Medical Institutions in the State of Telangana for block period 2016-17.

The following directions are given to the all the Private Un-aided Nursing & Para Medical Institutions in the State of Telangana relating to the fixation of fee structure for the aforementioned courses.

1. The Management shall not charge any Capitation Fee and there shall not be any profiteering. Except the aforementioned fee fixed by the Government, no other amount, either directly or indirectly, can be charged un-authorizedly or illegally by the Management. If any such other amount is charged un-authorizedly under any other head or guise (e.g donation etc.) it would amount to charging of Capitation Fee. The surplus (profit) that is generated from the collection of the Fee must be for the benefit of the Institution and cannot be diverted for other purpose or for personal gain.
2. The students admitted to the course during the academic year 2016-17; 2017-18; 2018-19 shall pay every year the same annual tuition fee as paid at the time of their admission till they complete the course.
3. The students who were admitted to the course prior to the academic year 2015-16 shall continue to pay every year the same annual fee at the rate existing at the time of their admission till they complete the course.
4. The institutions shall collect the Annual Tuition Fee every year in advance only for that particular year either in a lumpsum or in equal monthly instalments, if it so opts.
5. The Management of the Institutions are also informed that fixation of the Fee Structure by the Government will not by itself enable or permit the Management to run the relevant Courses if it is otherwise not duly recognized by the Government / INC / concerned University at any relevant time.
6. As contemplated in Rule 4 (V) of the AFRC. Rules issued in G.O.Ms.No.6, H.E (EC.2) Department, Dated: 08/01/2007, the Government has to notify the fee Structure determined by the TAFRC.

The Director of Medical Education, TS, Hyderabad / the Registrar, KNR University of Health Sciences, Warangal shall take necessary action in the matter accordingly.

MLT Courses in Private Un-aided Nursing & Para Medical Institutions in the State of Telangana for block period 2016-17.

2. As per the instructions issued in the reference 3<sup>rd</sup> read above, a Committee has been constituted under the Chairmanship of DME, Telangana, Hyderabad to examine the representations of Associations in the references 2<sup>nd</sup> and 4<sup>th</sup> read above, and after examination, the committee has submitted its report in the reference 5<sup>th</sup> read above.
