**Notification for FINAL Phase of counseling for MDS Courses for
Competent authority Quota seats in Dental Colleges under KNRUHS
for the Academic Year 2017-18 in Telangana State**

NOTIFICATION

In continuation of earlier notification dated 10.4.2017, 17.4.2017 and 10-05-2017, the University proposes to conduct Final phase of counseling for MDS seats under Competent Authority quota for the academic year 2017-2018 in the state of Telangana.

(a) To fill up the vacant seats, left over after 1st phase of counseling.

Eligible Candidates, whose names are notified in the final Merit list on KNRUHS website only can exercise web options for admission into MDS course for Convener quota seats in Government and Non-Minority Private Dental Colleges as detailed above from 6.00 AM on 25-05-2017 to 10.00 AM on 26-05-2017.

The candidates who secured admission in 1st phase of counseling and wish to change their college/course according to their merit, can exercise their web options. Candidates are informed that, once MDS seat is allotted in the Final phase of counseling as per their web options, the seat allotted in 1st phase of counseling is automatically cancelled and re-allotted to other candidates in the same phase.

For eligibility criteria and regulations referred to first notification dated: 10-04-2017, 17-04-2017 & 10-05-2017.

FEE:**

Rs. 17,600/- for MDS Courses have to be paid for obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

The candidates who have already secured a seat and joined and are willing to slide from one Dental College to other Dental College in Telangana need not pay University fee again.

TUITION FEE: As per existing Government guidelines for Govt. / Pvt. (Minority/ Non-Minority) Dental Colleges vide G.O. Ms. No. 41 .

INSTRUCTIONS TO CANDIDATES:

1. Candidates while giving options should note that the seats vacated by the candidates selected in first counseling and slided to other college / course during Final phase of counseling process will be added & allotted simultaneously during Final phase of counseling itself. Hence, candidates are informed to give options for all seats in all colleges irrespective of vacancies shown in seat matrix. Candidates are advised to give options to the courses in which they are interested, so as to give chance to next meritorious candidates.
2. The details of vacant seats available will be placed in the www.knruhs.in / <http://tsmds.tsche.in> before counseling.
- 3) The candidates can exercise web options through:
<http://tsmds.tsche.in> - for MDS Courses in Govt. Dental Colleges, Hyderabad and Private Dental College in Telangana State.
- 4) Candidates can give web options from home / any other place having internet facility. Candidates can also give web options from helpline centre at PGRRCDE, OU Campus, Hyderabad.
- 5) One Time Password will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z (for details read instructions to the candidates before giving options).
- 6) Candidates opting for MDS courses are informed that, there is no limit for exercising options, candidates can give options for any number of subjects, the candidate is interested to join in any of the Dental Colleges.
- 8) The selected candidates shall download the allotment letter from website after payment of the University fee by gateway method by using Online payment method. (Debit Card/Credit Card/Internet Banking).

9) Selected candidates have to report at the respective colleges on the dates specified on the allotment letter with all original certificates, submit the bonds and pay the college fee to complete the admission process.

10) Candidates who have joined in Final Phase of counseling are not permitted to withdraw from the seat. Candidates who have joined in earlier phase of counseling also cannot withdraw from the seat after Final phase of counseling. Candidates have to pay the discontinuation penalty of Rs. 5.00 Lakhs and they will be debarred for three years from applying for subsequent counseling as per G.O. Ms. No. 27 HM&FW (C1) Dept., Govt. of Telangana, Dated: 10-04-2017.

11) In partial modification of earlier proforma for BONDS, the bond should be signed by the candidate and their Father / Mother / Guardian. There is no need for sureties to be given by Gazetted officers.

12) The University fee and other fees once paid shall not be refunded under any circumstances.

13) Candidates can call helpline centres on 9502001583 & 8466924522 for any assistance.

14) The candidates already selected and joined in MDS Course in the state of Andhra Pradesh under NTRUHS Vijayawada are permitted to join by production of receipt of certificates and relieving certificate / discontinuation certificate issued by Principal of concerned Dental College in Original only.

15) The University fee and other fees once paid shall not be refunded under any circumstances.
